ROADWAY EASEMENTS and/or ROAD RIGHT-OF-WAY

Easements and Road Right of Way extend well beyond the paved areas. Within the Right-of-way there are a number of facts the bordering property owners should know. Most importantly the property is owned and controlled by the Town. It can be used for roads and other maintenance including widening the roads during snow removal. Any landscaping in these areas is therefore vulnerable to periodic disruptions and the Town is not responsible for reseeding any portion of the right of way that residents have taken upon themselves to seed or landscape. Shouldering along the right of ways will be done periodically especially when roads have been recently paved. The normal width of road and Right of Way is 66 feet. Asphalt is usually 24 feet with the rest (21 feet on each side of the asphalt) being the right of way. Any building of fences or concrete driveway approaches in road right-of-way is prohibited. Encroachments or obstructions is strictly prohibited per Municipal Code Section 8.02.

MAIL BOX INSTALLATIONS

Mailbox installations must comply with Post Office requirements, these requirements are available from your local Post Office. The box itself may be in the road right-of-way, but must be a minimum of one foot away from the road surface and be sturdy enough to withstand snow loads from snowplowing. Any damage done to mailboxes from snow load is not the responsibility of the Town. The mailbox and post may not cause a safety hazard for road traffic.

(Not Accepted at Town's Recycling Center, Oil Containers Cannot Be Recycled) - Please place with your trash

Brush, yard waste, leaves & grass clippings.

Town residents may bring brush, yard waste, leaves and grass clippings to the supervised Leaf & Yard Waste Facility located on Sleeping Dragon Road between Hillside and County Highway NN between the hours of 8:00 & Noon on every Saturday in May, October & November and on the first and third Saturdays of the months of June, July, August & September. This service is intended for light yard clean up, not for tree cutting. Branches should be no longer than 10 ft., and 4 inch diameter. No building materials can be dropped off at this site. Chips will also be available for residents to pick up at this location during operative hours. All containers or bags must be removed.

Christmas Trees

During **January**, the Town will accept Christmas Trees, Wednesday or Saturday during the recycling hours. An attendant will indicate the disposal area. All trimmings must be removed. All wire must be removed from wreaths.

Burning

The Town is in a Department of Natural Resources Air Quality Controlled Area. The Town of West Bend does not issue burning permits. IF burning within the Town of West Bend you SHALL contact the Washington County Sheriff's Department and the fire department before you burn and inform them of the type of materials being burned, place of the burn and time of your burn. The Town will seek reimbursement of fire alarms produced by illegal burning, more than one alarm malfunction to which a fire truck had been dispatched, all false alarms (water sprinkler malfunction, smoke scare etc.) to which a fire truck has been dispatched. The cost by Ordinance for these types of calls is \$9,084.00. The Town of West Bend's fire protection cost is 60% of the Town budget. You will be charged the \$9,084.00.
