

Town of West Bend Town Board Minutes
July 14th, 2020

Supervisor Troy Zagel called the Town of West Bend Town Board **meeting to order at 6:15 P.M.**

Clerk Julie Ihlenfeld read the **Call of the Meeting**.

Roll Call was taken. Present: Supervisor Troy Zagel, Supervisor Mark Wagor, Clerk Julie Ihlenfeld, and Treasurer Bob Burgardt. Chairman Jim Heipp joined the meeting in progress.

Washington County Sheriff Department monthly call review. Washington County Deputy Sheriff Andrew M. Graper presented reports for June 2020. The Incidents Summary List contained 273 items. Monthly Case Overview Report contained 26 items.

Motion by Heipp to approve the Conditional Use Permit for James C. Ligon to build a detached garage located in the street yard per Plan Commission recommendation. Seconded by Zagel. Motion carried unanimously.

Approve Horlamus Rezone per Plan Commission Recommendation. Motion by Zagel to approve the Horlamus Rezone per Plan Commission Recommendation and approval from the City of West Bend. Seconded by Wagor. Motion carried unanimously.

Approve Gentle Dental Rezone per Plan Commission Recommendation. Motion by Heipp to approve the Gentle Dental Rezone per Plan Commission Recommendation and approval from the City of West Bend. Seconded by Zagel. Motion carried unanimously.

Approve Zerwinski Rezone per Plan Commission Recommendation. Heipp asked about the detached structure currently on the parcel. Zerwinski stated the structure will be removed. Motion by Heipp to approve the Zerwinski Rezone per Plan Commission Recommendation. Seconded by Zagel. Motion carried unanimously.

Discussion/Action re: Golf Cart Ordinance Update. Proposed update to exclude golf carts on Paradise Drive from 18th Ave to Hwy Z. Item is tabled until thorough review of town roads.

Discussion/Action re: Firearms Ordinance. Wagor presented the proposed Firearms Ordinance. See attached.

Granting of Bartender license. Motion by Heipp to approve 6 bartender license applications, 3 new and 3 renewals. Seconded by Wagor. Motion carried unanimously.

Discussion re: Fire Calls. Two fire calls in June 2020.

Other correspondence received by the Clerk and/or Town Board to be discussed at next months meeting. Complaint received regarding Big Rivers. Discussed garbage and recycling.

Motion by Heipp to adjourn, seconded by Zagel. Motion carried unanimously to adjourn the meeting at 7:15 p.m.
