

Town of West Bend Town Board Minutes
June 18th, 2020

Chairman Jim Heipp called the Town of West Bend Town Board **meeting to order at 9:30 A.M.**

Chairman Jim Heipp read the **Call of the Meeting.**

Roll Call was taken. Present: Chairman Jim Heipp, Supervisor Troy Zigel, Supervisor Mark Wagor, Clerk Julie Ihlenfeld. Treasurer Bob Burgardt was excused.
