Ordinance # 2018-07

ORDINANCE TO REPEAL AND RECREATE PART OF CHAPTER 7 OF THE MUNICIPAL CODE RELATING TO PARKING REGULATIONS.

THE TOWN BOARD OF THE TOWN OF WEST BEND, WASHINGTON COUNTY, WISCONSIN DO ORDAIN AS FOLLOWS:

Section 1. That section 7.05 (1) of Chapter 7 of the Municipal Code be amended as follows:

7.05 PARKING REGULATIONS. (1) Parking prohibited at all times except temporarily for the purpose of and while engaged in loading or unloading or in receiving or discharging passengers or property and while the vehicle is attended by a licensed operator so that it may be moved promptly in case of an emergency or to avoid obstruction of traffic, no person shall at any time park or leave standing any vehicle upon any of the following parts of highways.

- (a) Reisch Road from State Hwy 33 to the dead end
- (b) Paradise Drive, between S. 18th Ave, and east shore of Big Cedar Lake
- (c) Scenic Drive from CTH NN and Z to Paradise Drive
- (d) Boat Launch Road, for the entire length
- (e) Hacker Drive from CTH Z to the dead end
- (f) Artist Bay Road from Hacker Drive to the dead end
- (g) Gonring Drive from State Hwy 144 to the west shore of Big Cedar Lake
- (h) Peters Drive from Paradise Drive to the dead end
- (i) Silver Lake Drive on east side from 3408 Silver Lake Drive going north to the dead end and No Parking on either side of dead end.
- (j) Schneider Court from Gonring Drive to the end of the cul-de-sac
- (k) Nabob Drive from State Hwy 33, south to Glen View Parkway entrance
- (l) Timmer Bay Road on the north side from CTH Z to corner by Uncle Dicks Road
- (m) West Lake Drive on the west side from Gonring Drive to State Hwy 144
- (n) All of the Westerly side of Point Drive
- (o) Hron Rd both sides from CTH NN to Town Termini
- (p) Silver Lake Drive – both sides from 5476 Silver Lake Drive to turnaround at 5519 Silver Lake Drive
- (q) Silver Lake Drive – both sides from 5476 Silver Lake Drive to 5500 Silver Lake Drive
- (r) Timmer Bay Road – south section of Timmer Bay Road from CTH NN to the Private Drive section of Timmer Bay Road
- (s) Maple Ridge Drive – both sides from Hwy 144 to Cedar Lake Drive
- (t) Boettcher Drive – both sides from Cedar Park Drive to Hwy 144
- (u) Maple Ridge Court - both sides from Maple Ridge Drive to Cedar Lake Drive
- (v) Wildflower Lane - both sides to Cedar Lake Drive
- (w) Cedar Lake Drive - both sides from Cedarview Drive to Wildflower Lane
- (x) Cedarview Drive - both sides from Hwy 144 to Cedar Lake Drive
- (y) Cedar Lake Dr. from Wildflower Lane past Maple Ridge Dr. and around the corner before Maple Ridge Court to corner.

Section 2. This ordinance shall take effect upon passage and posting as provided by law.
